legislative highlights:

- <u>Annual Budget:</u> The Mayor released his budget on March 2, 2022. Check out the budget process page for more information.
- Resolution 22-35: Approving Collective Bargaining for UPW Bargaining Unit 1. This is important as it sets the base for other union collective bargaining agreements and will affect the budget going forward.
- <u>Bill 9 (22)</u>: To address the taxation of vacant residential properties in the City through an empty homes tax. This is a work in progress and welcome public suggestions as we work with administration to create an enforceable
- <u>Bill 41(21):</u> To better protect the City's residential neighborhoods and housing stock from the negative impacts of short-term rentals by providing a more comprehensive approach to the regulation of transient accommodations within the City.
- <u>Real Property Tax Assessments</u>: The Real Property Assessment Division shared a presentation sharing assessments. Tongan Relief Event

The United Korean Hawaii
Association (TUKHA) volunteers

Items in the shipment included building materials, portable butane stoves, cases of bottled water, ramen cups (dry), bagged rice, paper towels, toilet paper, disposable diapers, feminine hygiene paper products, trash bags, canned foods.




From March to June, the Council carefully deliberates the City's budget package. which includes the Executive Operating and Capital Budgets, the Legislative Budget, and the HART Operating and Capital Budgets. This three month process is the only opportunity for the public to suggest alternatives to the Mayor's proposals by voicing their opinions directly to Councilmembers.

It is through the budget deliberation process, that Councilmembers are able to directly respond to constituency concerns. Councilmembers may propose budget amendments to include funding that addresses specific district needs and ensures that quality services are provided to the public in the ensuing fiscal year. In this sense, it is the Council's role to be the "checks and balances" for the public throughout the budget decision making process.
